#### CAROLE HENDERSON HOLIDAY DOUBLES TOURNAMENT RULES

This tournament was named for Carole Henderson, whose dedication to youth bowling and her willingness to spend countless hours coaching and encouraging young bowlers, allowed her to touch and influence hundreds of bowlers in the Colorado Springs area. There are some 2<sup>nd</sup> and 3<sup>rd</sup> generation families of bowlers who share fond memories of Carole's dedication. Carole unselfishly gave to the young bowlers of our community.

**1. Eligibility:** This tournament is open to all current PPUSBC Youth and Adult bowlers. Youth bowlers cannot have reached their 18th birthday as of August 1, 2024, and must have maintained compliance with USBC Youth Rule 400. Participants may be required to show a current USBC membership card at check-in. Non-USBC and/or non-PPUSBC bowlers will be required to pay the required membership fees prior to bowling.

**2. Participation:** This is a doubles tournament consisting of 3 games. Doubles partners will be 1 adult and 1 youth. Multiple participation is allowed. However, a bowler may place only once with the same partner but may place more than once with different partners. An adult may bowl with more than one youth at the same time, or a youth may bowl with more than one adult at the same time. In either instance, the bowler with multiple partners will pay linage only once, linage is \$12.00 per 3 game series.

**3. Entry Fee:** The combined entry fee will be \$40.00 broken down as follows: prize fund paid in the form of scholarships of \$14.00 and expenses of \$26.00. PRIZE FUND WILL BE RETURNED 100% in the form of awards and scholarships.

**4. No Refunds**: No team or individual shall be entitled to a refund once the tournament begins. Prior to the start of the tournament, a refund may be given if the team or individual notifies the tournament manager or tournament director that they will be unable to bowl.

5. Prize Ratio: 1 in 5 entries per division. Each youth winner will receive an award. In the event of a tie, duplicate awards will be given. Results will be posted to our Facebook page and website: www.pikespeakusbc.com. Scholarship amounts will be determined by the number of entries. Scholarships will be managed by SMART through USBC. Bowlers will have EIGHT years from high school graduation to use the scholarships. Expired ones will revert to the PPUSBC Youth Scholarship Fund.

6. Averages: All bowlers use the highest PPUSBC book average of 21 games for adults and 12 games for youth from the 2023-2024 season. If no book average, use the current league average of 21 games or more for adults and 12 games or more for youth as of November 30, 2024. If a participant does not have either average, an assigned average for youth bowlers will be (age as of August 1, 2024): Age Division are as follows: Under 8. Under 10. Under 12. Under 15 and Under 18

Assigned averages for men will be 230, and for women, 200.

7. Handicap: Handicap will be 90% of 230.

8. Dress Code: No hats, cutoffs, tank tops, muscle shirts, clothing with offensive language and/or pictures, or bare midriffs will be allowed. Shorts/skorts/skirts may be worn only if the said apparel is no shorter than the fingertips of the bowlers when their arms are extended straight down at their sides. No headphones or earbuds are allowed. No electronic devices will be allowed in the settee area. The tournament director shall have final say in compliance with the dress code. Failure to adhere to this rule will result in disqualification and forfeiture of entry fees and prizes.

9. Check-in Times: Check in will begin one hour prior to the squad time.

**10. Lane Assignments:** Lane assignments are made by the tournament director. If it becomes necessary to reschedule bowlers in any event, it will be done at the discretion of the tournament director. In case of a machine failure that makes it impossible to complete an event within the allotted time, the event will be rescheduled, and bowling will resume at the point where it was discontinued.

**11. Average Verification**: It is each bowler's responsibility to verify the accuracy of their average, whether submitted by the bowler or someone else. For youth bowlers, the PPUSBC 10-pin rule is in effect which means if a bowler has a current average that is 10 or more pins higher than the entering average, they must notify a tournament official prior to the start of competition. For adults, USBC rule 319 is in effect. Failure to use the proper average or make the correction, may disqualify the bowler and forfeit all entry fees.

12. Tardy Bowlers: Tardy bowlers will start in the frame being bowled when they are *ready* for tournament play. They will receive a score of zero for any frames missed. Bowlers refusing to start at the scheduled time shall forfeit their entry fee and will not be allowed to compete.
13. Substitutes: All substitutions must be made through the tournament office.

**14. Bowling Balls:** Once practice is over and competition begins, surface alteration will not be allowed. During competition, a bowler may clean their ball using a **shammy or dry towel only.** 

**15. Score Sheets**: After a score sheet has been signed by a contestant or team captain, it cannot be changed except in the case of an obvious error in scoring or calculation. Bowlers are cautioned to sign the score sheet only after ensuring its accuracy. Computer printouts from the participating center will be the official score sheets in all cases. These will be kept on file for ten days.

**16. Lane Breakdown**: In the event of a lane breakdown, play will proceed as follows: \*\*During competition, if bowlers sit for more than 10 minutes or are required to move pairs, each bowler will be allowed one ball per lane to warm up. \*\*If the breakdown occurs during practice, the remaining practice time will be allowed to be completed following the repair.

**17. Protests**: Any protest pertaining to the interpretation or application of tournament rules must be submitted in writing to the tournament director, with a copy to USBC and filed in accordance with USBC Rule 329.

### 18. Additional Rules:

A) All food and beverages must be kept out of the settee area.

B) Only bowlers, tournament officials, or center staff will be allowed in the settee area. COACHES WITH RVP AND SAFESPORT WILL BE PERMITTED IN THE SETTEE AREA.

USBC rules and regulations will apply in all instances not specifically covered in the above rules as stated. The PPUSBC tournament director will make a ruling on all questions, disputes, and rules not covered by these tournament rules. No use of tobacco products or consumption of alcoholic beverages during the tournament.
